RULES & REGULATIONS:

In addition to EA & the QCAS & Roma Show Society Rules & Regulations listed at the Roma Show Society website, the following will apply to this section: -

1. The organising committee reserves the right to change this program at any time & prizes/prizemoney.
2. Refunds: A 50% refund will be given for stabling & entries only on sighting a doctors or veterinary certificate. 100% refund will be given if the scratching is before the closing date.
3. Entry Changes: **No new horse entries will be accepted after the closing date.** No changes will be accepted after 5pm the previous day.
4. Horses may only complete in **1 Championship Class** for the duration of the show. Competitors must nominate in one event only for concurrent classes.
5. All placegetters MUST present for prizes mounted, or prizemoney is forfeited.
6. Cancelling of Event: If the event is cancelled prior to its commencement 90% of all entries, stabling & camping moneys will be refunded.
7. Classes 1A & 8 are restricted to riders that are in the Maranoa District postcode 4455. Evidence of residency may be requested at the judge's discretion.
8. Protests: In the event of a dispute, the QCAS rules shall apply. The Chief Stewart shall have the power to ban from competition any competitor whose behavior to an official, steward and/or volunteer is considered offensive by the Judge or Chief Steward. Persons must lodge protests with \$100 (inc. GST) bond in writing to the Secretary which will be forfeited if the protest is turned down and refunded if protest is upheld.
9. All prizes and prize money are to be collected from the Head Steward by Sunday, 14th May 2023 (or as per any other arrangement made directly with the Head Steward). After this time, any unclaimed prizes will be dealt with in accordance with legislative requirements. At all times, it is the sole responsibility of the winner to collect his or her prize.
10. Competitors Declaration - All competitors and exhibitors have read and understand the Rules and Regulations and agree to be bound in all respects by these Rules and Regulations. Competitors and exhibitors also consent and agree that the Roma Show Society has the right to take or use photographs of him or her (and/or your property) and use the photos in any and all marketing and media worldwide, including online, now and in the future. All entrants compete at their own risk. No claim in any form shall be made by the entrant, their families, friends and/or representative against the Roma Show Society or person/s associated with the holding of the competition/exhibit.
11. Article 255 – Amateur Riders
Amateur Rider classes are classes for Athletes who:
 - Must not have competed in an Olympic Games or World Equestrian Games in either Jumping or Eventing
 - In the past 10 years must not have competed in a World Cup for Jumping Riders qualifying round.
 - Must not have competed in section 1 and 2 at a Royal Show in Sydney, Brisbane, Melbourne, Adelaide or Perth in the past two years
 - Amateur Riders may not compete in an Amateur class if they compete in a class where the first round is higher than 1.20m at that show. 1.1 Athletes must meet the membership requirements as set out in the EA General Regulations.
1.2 Athletes may compete as amateurs from the beginning of the calendar year in which they turn 21 years of age.

1.3 Organisers may at their discretion limit the number of horses a rider can start.

1.4 The course shall be free-flowing and relatively simple. The first obstacle in the first round should be 10cm lower than the advertised starting height of the competition.

1.5 There will be a maximum height rise of 10cm for the jump-off

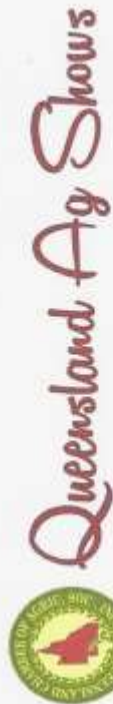
