1. The Roma Show Society Inc reserves the right to reject any application in its sole discretion and its decision in this regard shall be final.
2. The Final Placement of stalls is at the sole discretion of the Roma Show Society Inc although applicant's preference as to site, will be considered.
Your preferred site is not guaranteed.
3. All exhibitors and itinerants **must** contact the Machinery Alley Steward before bumping in.
4. Entry will be between 8:00 am and 6:00 pm Wednesday to Thursday of the week of the show. *Thursday is only a competition day, but itinerants may feel free to sell and or display their goods.*
5. All displays, stalls, etc., must be in position by **Thursday night prior to show**, and must remain until **6:00 pm** on Saturday night, unless earlier removal is authorised by Machinery Alley Steward and the waiver has been signed. Please note vehicle traffic is NOT permitted from the Show opening until close.
6. Any space where full payment has been received and is not occupied by Thursday 7:00 pm will be deemed vacant and will be reallocated as the Show Society sees fit and no monies will be refunded.
7. **No waste water** is to be run onto the grounds. **Itinerants must have their own sullage tanks.**
8. Political advertising is not allowed. The exhibitors must confine their business to that stated on the application form. No sub-letting is permitted. Hawking, Selling, Canvassing or distribution of printed matter is not permitted outside the area allocated, unless approval is applied for by the exhibitor and granted by the Roma Show Society Inc.
9. The Roma Show Society Inc reserves the right to have removed, any item it considers objectionable or dangerous which is offered to patrons for sale, display or as a prize given or distributed.
10. Exhibitors and/or their employees are to conduct themselves in an orderly and respectable manner within the showgrounds.
11. Exhibitors shall not excavate, dig or place pegs in their area without permission from the Machinery Alley Steward.
12. P.A. Systems, Sound Units or Projectors shall **not** be operated without the approval of the Machinery Alley Steward.
13. Exhibitors are responsible for supplying their own power leads, display stands, special lighting etc, and the removal of the same. All leads on the ground must be covered. Power Saws, Motor Mowers and Motorized devices shall **not** be operated without the approval of the Machinery Alley Steward. **ALL electrical items MUST have CURRENT ELECTRICAL TEST TAG attached.**
14. Fire Extinguishers, if required by the local Fire Brigade will be the responsibility of the Exhibitor, and will conform to Brigade requirements.
15. Space holders shall maintain access for emergency and Roma Show Society Inc vehicles and personnel at all times.
16. Exhibitors are to display their names prominently on their stands.
17. **No camping is permitted**, an area is available elsewhere in the grounds (beside Fashion Parade Area – power & water is available).
18. All supply vehicles must be removed from the area by **7:00 am** on operating days of the show. **At no time is a vehicle to be driven on the main grounds with receiving approval from the Machinery Alley Steward.** Itinerant car parking is allocated outside fence near entrance. Any deliveries from local business houses must be made within the time stated (7:00am) or if delivery needs to be made outside of time stock **must be** trolleyed in.
19. All exhibitors are required to abide by the Workplace Health and Safety Regulations, as stipulated in the booklet available from the Secretaries Office on arrival.
20. **The following items are not to be sold by itinerants: Fairy Floss, Dagwood Dogs, Waffles, Doughnuts, Snow Cones, Toffee Apples, Drug Related Goods (including cocaine kits, bongs etc), explicit and hard core T-Shirts, Fake Cigarettes, Fireworks or Crackers, Fuel type Fire Lighters (Zippo), Horns or Trumpets, Knives (including Pen Knives), Laser Pointers, Metal and Wooden Martial Art Nunchakas, Playing Cards (Nude or Lurid), Pressure Pack Snow, Pressure Pack Fart Gas, Silly String, Stink Bombs, Bouncing Beans, Shang-hi/sling shots, Bomb Bags, Fire Wallets or Water Bomb.**
21. **Toy Guns are acceptable, however the following are not: Ball Bearing Guns, Eight Shot Caps, Pellet Guns, Pop Downs (Throw Downs), Potato Guns, Replica Guns (Bullet Types), Roll Caps, Strip Caps, Water Pistols (over 150mm / 6"), Gel Blaster Guns or Sling Shots. All noise related items are banned. Samurai Swords, English Swords and Fencing Swords are to be sold In Sealed Packages by Licensed Traders ONLY.**
22. **All animals must be on a leash or a chain. Any dogs found wandering the grounds will be removed at owners cost.**
