CHARGES:

Forms are to be returned no later than 15th December 2021

- Space will not be allocated unless an application form has been submitted.
- On approval of your application, a Tax Invoice will be forwarded to you for payment. *Your site will not be guaranteed until payment has been received.*

DISPLAY AND/OR SALE OF GOODS:

- Applicants are to clearly state all types of goods that they wish to display and/or sell.
- Applicants are requested to give overall sizes of display vehicles including pulls, towbars, awnings, tents, pegs etc.
- Ideally, include a plan and photo showing your layout of display areas, entrances, front of vehicles etc.
- Roma Show Society holds the right to ask items to be removed from sale.

SETTING UP:

- All exhibitors can set up from 10am on Friday December 31st 2022 and must be ready for service from 6pm

RULES & REGULATIONS

The Roma Show Society Inc will ensure that all care is taken, but no responsibility will be accepted for damage, or loss however caused to any equipment, displays or stalls.

1. The Roma Show Society Inc reserves the right to reject any application in its sole discretion and its decision in this regard shall be final.
2. The Final Placement of stalls is at the sole discretion of the Roma Show Society Inc although applicant's preference as to site, will be considered.
3. You **must** contact the Groundspace Steward before setting up stall.
4. **No** waste water is to be run onto the grounds. **Itinerants must have their own sullage tanks.**
5. The Roma Show Society Inc reserves the right to have removed, any item it considers objectionable or dangerous which is offered to patrons for sale, display or as a prize given or distributed.
6. You and your staff are to conduct themselves in an orderly and respectable manner within the showgrounds.
7. Traders shall not excavate, dig or place pegs in their area without permission from the Groundspace Steward.
8. P.A. Systems, Sound Units or Projectors shall **not** be operated without the approval of the Groundspace Steward.
9. Traders are responsible for supplying their own power leads, display stands, special lighting etc, and the removal of the same. All leads on the ground must be covered where pedestrians have access. Power Saws, Motor Mowers and Motorized devices shall **not** be operated without the approval of the Groundspace Steward. **ALL electrical items MUST have CURRENT ELECTRICAL TEST TAG.**
10. Fire Extinguishers, if required by the local Fire Brigade will be the responsibility of the Exhibitor, and will conform to Brigade requirements.
11. Traders shall maintain access for emergency and Roma Show Society Inc vehicles and personnel at all times.
12. Traders are to display their names prominently on their stands.
13. **No camping is permitted in the Groundspace area**, space is made available elsewhere in the grounds (power & water is available).

14. All vehicles (including supply trailers) must be removed from the Groundspace area by before 5:00pm on Friday 31st December 2021. At no time is a vehicle to be driven on the main grounds without getting approval from the Groundspace Steward.
15. All exhibitors are required to abide by the Workplace Health and Safety Regulations, as stipulated in the booklet available from the Secretaries Office on arrival.
16. The following items are not to be sold by itinerants: Drug Related Goods (including cocaine kits, bongos etc), explicit and hard core T-Shirts, Fake Cigarettes, Fireworks or Crackers, Fuel type Fire Lighters (Zippo), Horns or Trumpets, Knives (including Pen Knives), Laser Pointers, Metal and Wooden Martial Art Nunchakas, Playing Cards (Nude or Lurid), Pressure Pack Snow, Pressure Pack Fart Gas, Silly String, Stink Bombs, Bouncing Beans, Shang-hi/sling shots, Bomb Bags, Fire Wallets or Water Bomb. Toy Guns are acceptable, however the following are not: Ball Bearing Guns, Eight Shot Caps, Pellet Guns, Pop Downs (Throw Downs), Potato Guns, Replica Guns (Bullet Types), Roll Caps, Strip Caps, Water Pistols (over 150mm / 6"), Gel Blaster Guns or Sling Shots. All noise related items are banned. Samurai Swords, English Swords and Fencing Swords are to be sold I Sealed Packages by Licensed Traders ONLY.

Waiver, Release and Acknowledgement Form
